Background

A regulatory framework was created collaboratively between the British College of Aesthetic Medicine (BCAM), the British Association of Cosmetic Nurses (BACN), the British Association of Dermatologists (BAD), the British Association of Aesthetic Surgeons (BAAPS) and the British Association of Plastic, Reconstructive and Aesthetic Surgeons (BAPRAS). The two independent bodies enforcing this framework are the Joint Council for Cosmetic Practitioners (JCCP) and the Cosmetic Practitioners' Standards Authority (CPSA.)

Rationale

The inception of the Level 7 Diploma in Clinical Aesthetic Injectable Therapies aimed to establish uniformity in the caliber and curriculum of training accessible to non-surgical aesthetics practitioners. The Level 7 Diploma in Clinical Aesthetic Injectable Therapies has evolved into a pivotal qualification, now dedicated not only to standardising training quality and content but also to prioritising comprehensive knowledge among our delegates.

Our primary goal is to equip practitioners in the non-surgical aesthetics sector with the **highest caliber of expertise**, ensuring not only excellence in practice but also paramount safety within the industry.

As a result, stricter overarching regulations are being implemented, narrowing the field of practitioners eligible to meet the required standards for practice to those possessing appropriate qualifications. Who is eligible to enrol?

Doctors, Dentists, Dental Therapists, Nurses and Prescribing Pharmacists registered with the relevant medical council.

What is needed to enrol on the diploma?

- Valid GMC/GDC/NMC/GPhC/RPS pin number or international equivalent.
- English as a first language or International English Language Testing System (IELTS) score of 7.0 or more.
- International students may be accepted if an equivalent level of education can be demonstrated - please contact our course experts for further discussion.

How long will it take to complete

Although the official completion deadline is set at 24 months, our observation indicates that delegates typically finish anywhere from 6 to 18 months after beginning their learning journey. The duration of training is subject to individual circumstances, such as employment and family commitments.
